1) The end users are authorized as intermediate consignees for the purpose of distributing the commodities to the Cuban people.

3) The items may not be used to enable or facilitate the export of goods or services from Cuba that primarily generate revenue for the Cuban government.

4) State-owned enterprises, agencies, and other organizations of the Cuban Government that are intermediate consignees or ultimate consignees or purchasers must provide the items for the end use and benefit of the Cuban people.

5) For agricultural commodities:

A.) If your export is a donation or a commercial sample, no contract is required. You may make shipments that have been authorized for export by this license only if the shipments are made within 12 months of the validation date of this license.

B.) If your export is a commercial sale, you must have a signed contract prior to shipping any of the agricultural commodities you have been authorized to export by this license. 1) If you already have a signed contract, you must ship the agricultural commodities that have been authorized for export by this license and that are the subject of your contract within 12 months of the signing of the contract. 2) If you do not yet have a signed contract, you must sign a contract prior to export. In addition: (i) you must sign a contract within 12 months of the validation date of this license, and (ii) you may make shipments of agricultural commodities that have been authorized for export by this license and that are the subject of your contract only if the shipments are made within 12 months of the signing of the contract. No shipments may be made pursuant to this license later than 24 months after the validation date.
