We acknowledge received your correspondence detailing that your office is required to revoke or refuse to renew a BTR for any individual, business, or entity doing business with Cuba in violation of Federal law. We would like to clarify and provided you with any information needed in order to show your office that VA-CUBA INC is not doing business with the government of Cuba instead is providing services to the Cuban people under the licenses and registrations required in accordance with Federal and State regulations.

1. VA-CUBA INC is a Miami-based company with more than 50 years specialized in provides shipping, travel, and consular services to Cuba citizens. The company offers international reloads, tourist trip reservations, in addition to shipping various goods like food, medical supplies, and household appliances. We have multiple locations throughout Florida, including Miami, Hialeah, West Palm Beach, and Tampa.
2. VA-CUBA INC is providing services to the Cuban community of Florida as well as to the Cuban people in Cuba. No services are provided to the government of Cuba neither to any party related to the Cuban government as required by OFAC and Federal Regulations.
3. Our services are provided based on licenses and registration as mentioned below:
 - a. FinCEN registration which allows the company to provide the services of remittances which currently is on hold. See Attach # 01 FinCEN
 - b. State of Florida OFR – Office of Financial Regulation, FT2 License as a Money Transmitter which allow the company to provide the services of remittances within the state, and which is currently in hold due to there is no a party independent to the Government for providing such services.
 - c. A travel seller license allows travel agencies and agents to operate legally in the United States. See Attach # 02 Seller Travel .
4. OFAC Q&A 724: Do travel service providers (such as travel agents and tour group operators) need to obtain specific licenses from OFAC to provide services for travel to Cuba? 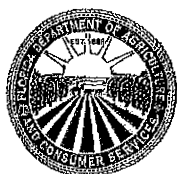

This letter responds to your request dated March 15, 2022, and further communications on June 27, 2022, to the U.S. Department of the Treasury's Office of Foreign Assets Control (OFAC), on behalf of Xael Charters, Inc. d/b/a Xael Travel Services, a U.S.-based travel and charter service provider headquartered in Miami, Florida (the Applicant), requesting a specific license, to engage in travel-related transactions in connection with the provision of travel services and air carrier services authorized by OFAC general licenses available at 31 C.F.R. section 572, as well as to participate in professional meetings to support authorized travel services and air carrier services (the Application). The Application states such a specific license would allow Xael personnel to travel to Cuba to engage in transactions incident to the provision of authorized travel services, such as arranging for ground transportation and gift package forwarding, and transactions incident to the provision of authorized carrier services between the United States and Cuba.

Specifically, Xael seeks a specific license to 1) engage in the travel-related transactions as set forth in section 515.560(c) of the Cuban Assets Control Regulations, 31 CFR Part 515 (the CACR) incident to travel to, from, and within Cuba, and such additional transactions as are directly incident to conducting necessary business (e.g., arranging for airline tickets, hotel accommodations, ground transportation, gift package forwarding, etc.) to provide the travel services authorized pursuant to 31 CFR § 515.572; 2) engage in the travel-related transactions as set forth in § 515.560(c) of the Regulations incident to travel to, from, and within Cuba, and such additional transactions as are directly incident to the safe operation of aircraft (e.g., coordination of aircraft safety, enabling operational safety, coordination of accident handling, and emergency response activities, including any necessary training in Cuba directly related to the above four areas), consistent with the requirements of U.S. Government regulatory authorities relevant to the flights between the United States and Cuba authorized pursuant to 31 CFR § 515.572; and 3) engage in travel related transactions as set forth in section 515.560(c), and such additional transactions related to professional meetings directly incident to the travel services and air carrier services authorized pursuant to section 515.572.

The Cuban Assets Control Regulations (CACR), administered by OFAC, prohibit all persons subject to the jurisdiction of the United States from dealing in property in which Cuba or a Cuban national has any interest of any nature whatsoever, direct or indirect, unless authorized by a general or specific license or exempt from prohibition. *See* 31 C.F.R. §§ 515.201.

Section 515.572(a)(1) of the CACR authorizes persons subject to U.S. jurisdiction to provide travel services in connection with travel-related transactions involving Cuba authorized pursuant to the CACR. Additionally, section 515.572(a)(5) of the CACR authorizes persons subject to U.S. jurisdiction to provide civil aviation safety-related services to Cuba and Cuban nationals, wherever located, to ensure the safety of civil aviation and the safe operation of commercial aircraft.

Note 3 to paragraph 515.572(a) states that section 515.564 authorizes employees, officials, consultants, or agents of persons subject to U.S. jurisdiction providing travel or carrier services or remittance forwarding services authorized pursuant to this part to engage in the travel-related transactions set forth in section 515.560(c) and such additional transactions as are directly incident to travel to Cuba for professional meetings in Cuba, such as those related to safety and security of flights to and from Cuba, or necessary to arrange for travel or carrier services or remittance forwarding to Cuba.

Section 515.533(a) of the CACR authorizes by general license all transactions ordinarily incident to the exportation of items from the United States, or the reexportation of items from a third country to any person within Cuba, provided that the exportation or reexportation is licensed or otherwise authorized by the Department of Commerce's Bureau of Industry and Security, subject to certain conditions. Additionally, section 515.533(c) authorizes the travel-related transactions set forth in 515.560(c) and such additional transactions as are directly incident to the conduct of market research, commercial marketing, sales or contract negotiation, accompanied delivery, installation, leasing, servicing, or repair of items consistent with the export or reexport policy of the Department of Commerce are authorized, provided that the traveler's schedule of activities does not include free time or recreation in excess of that consistent with a full-time schedule.

The proposed travel-related transactions in connection with the provision of travel and civil aviation safety related services and gift package forwarding appear to be authorized by the CACR to the extent transactions are consistent with the general license provisions set forth in sections 515.572, 515.564, and 515.533 of the CACR. Accordingly, no further authorization is required from OFAC. OFAC does not issue specific licenses authorizing transactions authorized by general license. *See* 31 C.F.R. § 501.801(a). Accordingly, OFAC is closing this case without further action and without prejudice.
